What is it?

美国EB-5投资移民签证签证是什么?

• The EB-5 Visa allows an investor to obtain a green card, permanent residency and citizenship through making a capital investment in the United States.

美国EB-5签证允许外国投资者在美国投资获得绿卡居留权。

• The investor's spouse and unmarried children under the age of 21 may also be admitted to the U.S. on a two-year conditional period.

• If the investor's I-829 petition to remove conditions is approved, the conditions will be removed from the spouse and children's Green Card status as well.

What are the requirements of an EB-5 Visa?

• An EB-5 investor must make a capital investment in a commercial enterprise.

EB-5的投资者需要满足以下任一条件:一。在投资100万美元并至少雇十名合法雇员,保证雇用两年;二。在国家认可的低就业地区投资;三。在经政府批准的特定区域投资五十万美元。

• The investment must create or preserve at least ten (10) full-time jobs for qualifying U.S. workers within two years.

• The Capital Investment means an investment of cash, equipment, inventory or other tangible property. The source of the investment must be acquired by lawful means and cannot be borrowed, though the source can be a gift.

How to obtain an EB-5 Visa:

• Establish a lawful business entity or invest in an existing business.

• File Form I-526, Petition by Alien Entrepreneur.

• Upon approval of Form I-526 petitioner, either file:

- Form I-485 Application to Register Permanent Residence or Adjust Status; or

- DS-230 or DS-260 Application for Immigrant Visa and Alien Registration
 申请DS-230 或 DS-260 移民签证和外国人居住美国注册

• Upon approval of the I-485 application or upon entry into the United States with an EB-5 immigrant visa, the EB-5 investor and dependents will be granted conditional permanent residence for a two-year period.

I-485 通过后或者得到EB-5移民签证,投资人和其未成年子女可以合法有条件的在美国居住两年。

• Then file form I-829, Petition by Entrepreneur to Remove Conditions, 90 days before the two-year anniversary of receipt of the Green Card.

• If the I-829 is approved, the conditions will be removed from the EB-5 applicant's status and the EB-5 investor and dependents will be allowed to permanently live and work in the United States
